



PROCEDURE FOR FUNDING

**For the installation of the "Jewel of Africa" or other projects
Through RK BOT Program's 100% financing**

I - TENTATIVE AGREEMENT

The following are required to enter into a tentative agreement:

1. Letter of Manifestation of interest
2. Executive Summary or Brief Executive Summary of the Project;
3. Profile of the CEO or Executive Officer in charge;
4. Copy of Certificate of Incorporation;
5. Company-Business or Nation State Profile;
6. Copy of the passport of the CEO or Executive Officer in charge;
7. Bank Detail Information (in the case of Nation State, National Bank Information);
8. CRCI Client Info Registration;
9. Business Admission Template Set;
10. Two sets of KYC documentation
 - a. KYC documentation for a client account with CRCI;
 - b. KYC documentation authorizing transfer to the Financial Partner;
 - i. Name and Title of Board of Directors
 - ii. Name and Title of Government Officials
11. Authorization Letter verifying authenticity funds payment service to CRCI;
12. Resolution of the Business Board of Directors.

II - CONSTITUTION OF ONE MILLION US DOLLARS (\$1 MILLION USD)

The following conditions must be met:

- A. Signing of the Non-Circumvention & Non-Disclosure Working Agreement between the Company or State and CRCI;
- B. A mandate allowing CRCI to act on behalf of the Company or Nation State must be provided, and consultation fee payment of One Million US Dollars (\$1 million USD) to CRCI;
- C. Irrevocable Masters Fees Payment Letter of Firm Commitment;**
- D. Client must pay Five Thousand US Dollars (\$5,000 USD) to obtain any CRCI paperwork;
- E. Client must pay Two Thousand US Dollars (\$2,000 USD) per day for consultation meeting (The first consultation is free of charge).

III - PROVISION OF THE AMOUNT

The following are required:

1. 20% BG cash Proof of Funds of the project (when applicable);
2. Payment of One Million US Dollars (\$1 million USD) consultation fee;

PROCEDURE FOR FUNDING

The approval will take no more than 20 business days after receipt of the consultation fee.

NB: There are no additional fees aside from that of the consultation fee. RK B.O.T. PROGRAM provides for 100% of the project financing, and does not require a sovereign guaranty.

The above list is not all-inclusive. It is possible that during the evaluation of the documents provided, the Financial Partner may require other documents not provided for on the list.
